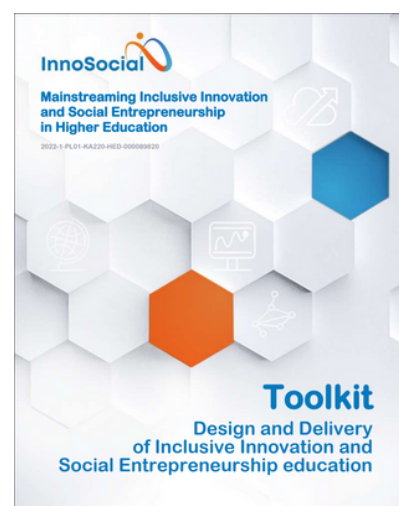


Mainstreaming Inclusive Innovation and Social Entrepreneurship in Higher Education

It is based on desk research, including literature review and analysis of study programmes/courses in the field of II&SE, as well as on consultations with stakeholders carried out either as panel discussions or individual interviews in Poland, Bulgaria, Italy and Lithuania.

DEVELOPING TEACHING AND LEARNING RESOURCES IN INCLUSIVE INNOVATION AND SOCIAL ENTREPRENEURSHIP

After developing the **Toolkit for design and delivery of Inclusive Innovation and Social Entrepreneurship education**, Partners have started working on the course in the same field, based on the analysis of existing curricula and suggestions of key stakeholders. Syllabus and learning materials will reflect on the ideas of teaching “About”, “For” and “Through” innovation and entrepreneurship.



The course will have knowledge-oriented, skills-oriented and experiential modules, composed of several units. The main aim is to develop educational resources in Inclusive Innovation and Social Entrepreneurship, that – if taken together – will form an educational course in this given field, or – if used separately – could be integrated into the existing HE courses and study programmes. The course will be integrated in the education offer of the Universities involved in the project – SAN (Poland), UNIPV (Italy) and VIKO (Lithuania).

The Course will contain not only the theoretical knowledge on Inclusive innovation and Social entrepreneurship, but most of all, case studies and practical assignments.

The educational materials developed will be available to all universities and students, and the individual components can also be used by other organisations. Follow our project website and social media. The results of our work will soon be presented there.

Second Transnational Project Meeting in Sofia Bulgaria



On September 7-8, 2023, the InnoSocial partners gathered in Sofia, Bulgaria, for the Second Transnational Project Meeting hosted by Tetra Solutions Ltd. The meeting was dedicated to the final review of the Toolkit for Design and Delivery of Inclusive Innovation and Social Entrepreneurship Education, as well as to the joint development of the course in the same field, based on the analysis of curricula and consultations with key stakeholders. As a result of this meeting, partners finalized the course structure and agreed about the intended learning outcomes and teaching methodology. At the end of the meeting, the Coordinator provided an update about the project management issues and the InCREA team presented a summary of the project dissemination activities carried out by the consortium members thus far.
